Eligibility Requirements for an Official to be Assigned:

(2025-2026 Rules & Policies, Page 26-27, Chapter 6, section III, E.)

- Active Member of the organization to which they are being assigned. (Ex. USAG, NGA, Etc.)
 - a. Must be current on all membership requirements.
 - b. Must have submitted CPE requirements by **July 31st** to be eligible for assignments. Officials **CANNOT BE** assigned if CPE is not up to date. (if it is an absolute necessity to assign an official delinquent on CPE requirements then that judge's compensation is reduced by (\$5/hour) regardless when they get current)
 - c. Certified and actively judging at the level of meet assigned.

Assigning Process for Local, Pre-Sectional and Sectional Competitions:

(2025-2026 Rules & Policies, Page 27, Chapter 6, Section III, H.)

- Assignments start on August 1st each year, following these priorities in the order of importance:
 - 1.) CPE compliant properly rated officials
 - 2.) Request by the Meet Director for specific judges or specific ratings.
 - 3.) Minimum rating required to judge the specific meet.
 - 4.) Geographical location of the meet with preference to keep costs down for the Meet Director.
 - 5.) CPE non-compliant officials will be assigned **ONLY** if there are not enough CPE-compliant officials available.

<u>Please note:</u> Holding a specific rating does not ensure a judging assignment.

Assigning Process for State, Regional and National Championships:

(2025-2026 Rules & Policies, Page 27, Chapter 6, Section III, I. J. K.)

- Judging selections to the State, Regional and National championships are explained in the 2025-26 USAG Rules and policies and <u>are not</u> the responsibility of NAWGJ-NYN.
- Criteria and process for selecting judges for State and Above competitions are chosen by the State USAG committee (Larry Goldsmith, Chair) and Regional Committee (Michelle Archer, Chair)

NAWGJ-NYN will be using the GymJas judging assigning system:

In order to ensure assignments and contracts are being assigned according to USAG Rules & Policies, we have adopted the below guidelines to be adhered to by our NAWGJ-NYN membership.

- 1. Members need to make sure all personal information is accurate and complete on the GymJas website (ex. Email, phone #, address, etc.)
- Members must be sure posted membership expiration dates are valid and compliant
 - a. (Ex. Safesport, Background, CPE, etc.)
- 3. Members availability must be kept up to date; any changes should be made in a timely fashion.
- 4. If you decline a contract for a date you had previously marked as available, your name will be moved to the bottom of the availability list for that date.
- 5. Multiple declines within a period can result in loss of an assignment(s) (Ex: Choose to decline a meet for a better assignment, Availability not kept current resulting in multiple declines.) Keeping your availability updated can avoid having to decline an assignment.
- 6. Assignments must be **accepted** or **declined** within two (2) weeks of the date of the request.
- 7. If an official is unable to fulfill their obligation due to personal reasons after submitting the contract, they may be required to reimburse certain expenses according to USAG policies. (2025-2026 Rules & Policies, Page 25, Chapter 6, Section I, G. 1. b..)
- Missing or inaccurate information on your GymJas profile can impact communication with the assignor, potentially leading to fewer assignments.
- 9. Officials are responsible for listing any affiliation on their GymJas Profile. Refer to USAG Rules & Policies for guidance. (2025-2026 Rules & Policies, page 26, Chapter 6, Section II)
- 10. All assignments are made according to Meet Director requests and adhere to USAG guidelines, with the goal of minimizing costs for the Meet Director.
